

In the fast developing and competitive world, AI is said to be a boon as it reduces human error, increase productivity and aids in speedy decision making process. From self-driving cars to perform surgeries, AI has widened its scope and in almost all spheres. AI is slowly heralding in Law and legal profession. However we cannot keep ourselves aloof from its threats. AI may pose certain threats such as loss of jobs, programmed to commit crimes, misaligned goals, Social manipulations, Invasion of privacy etc. However in India, AI is still in its early stages. Since AI is an emerging issue, today we may not be facing with the perils connected with it. But in near future many

concerns may arise with respect to AI. No doubt, NITI Aayog released a policy paper, National Strategy for AI in June 2018, which considered the importance of AI in different sectors. While all these developments are taking place on the technological front, there is no comprehensive legislation to regulate this growing industry. With the dearth of clear provisions in Law, accountability for the acts of AI may affect us in terms of Privacy to a great extent, as well as other spheres of law too. Therefore there is pressing need to have laws that regulate the actions of AI. With this background this seminar is organised to cater to the need of a robust AI legal regime in India.

- Should confirm to the standard laid down in The Bluebook (20th edition, 2015).
- Citation should be in the form of footnotes only.
