# WhatsApp (Regulation of Group Chat) Act, 2019: A Brief Overview

Call me an authoritarian, but I believe there ought to be a code of conduct which must be strictly enforced if we are to expect some sense of calm in the chaos that is group chat.

Ah yes, the group chat! -The genesis of every surprise birthday party and every college reunion.

What starts out as a fairly innocent attempt to bind members of a virtual tribe and guard against the outsiders, quickly spirals out of control - before you know it, the group becomes a toxic place where the once estranged (and now united) members become divided over their loyalty to IPL teams which finally ends in the dramatic exit of member. "Rahul has left the chat"

To regulate this rather unregulated virtual space I had taken it upon myself to draft some rules in public interest. Here's a brief overview of some of the important provisions of the WhatsApp Act, 2019:

The Preamble of this fictitious piece of legislation is fairly simple and reads thus:

"To strive for a safe space where opinions are expressed and respected but also controlled and regulated."

Section 1: Scope of the Act - the Act applies to the all groups irrespective of the nature, size or purpose of the group. The term "as soon as possible" is defined in Section 2(r) to mean "as soon as practically possible for the individual member concerned according to the facts and circumstances of the case." There is a corresponding duty on the member who poses the question to keep the question short and avoid being too verbose.

Section 8: Language of the group - clause (1) of this Section makes it amply clear that any use or attempt to use the short form "k." as a response in the group is strictly prohibited. This Section must be read with Section 4. If a member has a pattern of sending k. especially after a very long text of well phrased sentences by a member, the admin can avoid refrain from adding the lazy member to the group or even remove him from it. Yes, it's precisely this single lettered response that qualifies a member to be forever expelled from all groups. But this draconian sanction of expulsion should not be imposed as a matter of routine. It must be applied only as a last resort. He must first be given an opportunity to be heard. If his justification for using the cringe worthy response k. in this age of predictive text is that it helps "save time", the admin must consider deporting him to USA where he would thrive among the likes of President Trump who justified his use of the term "Tim Apple" instead of "Tim Cook of Apple" as a time saver. Such people are an embarrassment to our nation and would be better utilized to Make America Great Again.

The emoji equivalent of 'k' is the thumbs up. But the thumbs-up emoji has always had a rather positive connotation to it thanks to Salman bhai and the tagline "aajkuchthoofanikarteinhain." After all, WhatsApp is no stranger to creating a thoofan like the storm it created with the video of a Zomato delivery guy eating out of a food parcel. The video went viral and probably so did whatever infection he was carrying!

Section 9: Forwarding pointless good morning and goodnight messages - reminding members what time of the day or night it is through forwards which are far from original with the words 'good morning' or 'goodnight' in cheap font against the backdrop of some flowers, scenery or acute baby is both, redundant and plain foolish. It shall result in the temporary suspension of the guilty member from the group. Repeat offenders will be bad mouthed to other group admins to prevent his induction into any WhatsApp group in the future.

Section 14: Protection of source - this Section prohibits any member of a group from compelling another to reveal his source of information when such other member shares a juicy piece of gossip on the group. The

information so shared shall be accepted at its face value and shall not be called into question for its authenticity. Any doubt as to its authenticity shall be dealt with at the time of trial for spreading fake news.

Section 19: Content control - members of groups formed for a specific purpose shall confine themselves to the discussion of only that which helps achieve the purpose for which it was formed. For example, an Apartments Owners Association WhatsApp group shall not entertain cat or dog videos unless it is used in furtherance of making the point that residents are not allowed to own pets as per the Apartment Bylaws.

Section 24: Dissolution of a group - ad hoc groups created for achieving a particular objective (such as a birthday celebration) shall be automatically dissolved on attaining the objective for which it was created (like the birthday in question) or within 6 months of its creation, whichever is earlier. This shall be done by the honourable exit of each member in a time bound manner. It may or may not be preceded by the customary text by the exiting member such as "bye guys, this was fun," or "see you soon," or "until next time" etc.

The Act came into force on April 1, 2019 and has since been in force after it received an overwhelming majority in both Houses of Parliament, cutting across party lines. The Act faced its first legal challenge on April 5th but successfully passed the constitutional test because in the words of the Supremely Court of India, "the legislation is well within the reasonable restrictions permitted by clause (2) of Article 19. Deal with it!"

"We carry our childhood with us." says Gary D. Schmidt. I realized this very much in my interactions with children. A wound in the childhood takes a lifetime to heal. I came across an incident which shook me off. A mother physically tortured her 5 year old kid. When will he be freed?



# A Walk down The Memory Lane



#### Importance of Compassion

"The plain fact is that the planet does not need more successful people. But it does desperately need more peacemakers, healers, restorers, storytellers, and lovers of every kind ... It needs people of moral courage willing to join the fight to make the world habitable and humane. And these qualities have little to do with success as we have defined it."

This quote by David W. Orr usually attributed to Dalai Lama – is something relevant to the present times where hatred is marketed in a big way for gaining power.

"Every child, at birth, is the *universal man*. But, as it grows, we turn it into a *petty man*. It should be the function of the education to turn it again into the original *universal man*..." - says Kannada writer Kuvempu.

A child does not have any sense about the nature of private property. It does not *discriminate*. However, the parents try their best to inculcate a sense about – *possessiveness* and *jealousy*. Parents try their best to tell a child that its toy belongs only to the child and it shouldn't give it to others. This, they feel, would develop a sense of responsibility about valuable things in life. The parents even try telling that they would feed the food to *others*, if it refuses to eat. This is where the child develops the sense of "us versus others" and the sense of jealousy.

The same differentiation about "others" has been used across countries to dehumanize selected groups of human beings. I see many people spreading hatred and sharing unverified information that would lead to violence. Is there no end to this? First they spewed venom against people out of the country and now against our own citizens. In the next stage, this hatred will become a habit and will be directed against their own loved ones! Martin Luther King said, "darkness cannot remove darkness, only light can. Hatred cannot remove hatred, only love can."

In the present day, we need to evaluate the role of the teachers. Teachers have an important responsibility of facilitating a fair dialogue and to promote love and harmony between groups. We need leaders who can carry the message of compassion both in words and action; and ask their followers to stop the hatred. Is it too much to expect?

The movie is about the plight of the manual scavengers. India is now an advanced country where we have meritorious candidates in IITs who have invented gadgets that can help us do daily chores easily. We have developed satellites and sent spacecrafts to moon. Yet, we do not have the technology to clear the underground drains. I would rather say, they do not have the commitment to create a technology that would result in humanizing a group. Human beings are made to get down into the septic tanks to clear the blockages.

The movie was made with a thin budget, yet it struggled to recover the investment. In a time when

movies that have a superhero thumping his chest, there is no space for a movie that shows the powerless and discriminated people! After watching the movie, I moved on to Crossword bookstore and picked up a book by Devdutt Patnaik and on the blurb, found a coincidental information that the city where the gods lived was named as Amaravathi. Probably, the director's take was that – big cities are built on the sweat of these workers, but then they lead a life under inhuman conditions.

When I shared the plot of this movie with a student, she asked me, "just imagine, if all these manual scavengers and workers are given good education and they move to better / humane jobs, who will be left to do that job? Don't you think, we all should be doing the sanitation job ourselves? And never have a separate class of people to do that." I nodded in agreement.

#### By the Rivers of Babylon

ಮಟ್ಟಿಗೆ ಸತ್ಯ? ನಮ್ಮ ಕಾಲು ತೊಳೆದು ಅದೇ ನೀರನ್ನು ಕುಡಿಯಲು ನಮಗೆ ಹೇಳಿದರೆ ಹಿಂದೆ ಮುಂದೆ ನೋಡುತ್ತೇವೆ. ಅದರೆ ಯಾವುದೋ ರಕ್ತ ಸಂಬಂಧ ಇಲ್ಲದ ವ್ಯಕ್ತಿಯ ಕಾಲನ್ನು ತೊಳೆದು ಅ ನೀರನ್ನು ಕುಡಿಯುವ ಮಟ್ಟಿಗೆ ಇಳಿದಿದ್ದೇವೆ ಎಂದರೆ ಒಮ್ಮೆ ಯೋಚಿಸಲೇಬೇಕಾದ ವಿಷಯ. ಇನ್ನೂ ಚರ್ಚ್ ಗಳಲ್ಲಿ ಒಂದು ಪದ್ಧತಿ ಇದೆ ಏನೆಂದರೆ ಒಂದು ತಿಂಗಳಿಗೆ ಒಮ್ಮೆಯಾದರು ಪಾಪ ನಿವೇದನೆ ಮಾಡಬೇಕು ಎಂದು. ಒಬ್ಬ ಗುರುವಿನ ಮುಂದೆ ಹೋಗಿ ನಾವು ಮಾಡಿರುವ ಎಲ್ಲಾ ತಪ್ಪುಗಳನ್ನು ಪಾಪಗಳನ್ನು ಹೇಳಬೇಕು ಆಗ ಅವರು ಒಂದು ಪ್ರಾರ್ಥನೆ ಮಾಡಿ ಹೋಗು ಮಗನೆ/ಮಗಳೆ ನಿನ್ನ ಪಾಪಗಳು ಕ್ಷಮಿಸಲಾಗಿದೆ ಅಂತ ಹೇಳುತ್ತಾರೆ. ಅವರು ಹಾಗೆ ಹೇಳಿದ ಮಾತ್ರಕ್ಕೆ ನಮ್ಮ ಪಾಪಗಳು ನಿಜವಾಗಿಯೂ ಕ್ಷಮಿಸಲಾಗುತ್ತವೆಯೇ? ನಿಜವಾಗಿಯೂ ನಾವು ಸ್ವರ್ಗಕ್ಕೆ ಹೋಗುತ್ತೇವೆಯೇ? ಎನ್ನುವುದು ನನ್ನ ಪ್ರಶ್ನೆ. ನಮ್ಮಂತೆಯೇ ಸಾಮಾನ್ಯ ಮನುಷ್ಯನ ಮುಂದೆ ನನ್ನ ತಪ್ಪುಗಳು ಹೇಳುವಾಗ ಅದನ್ನು ಕೇಳಲು ಅವನಿಗೆ ಎಷ್ಟು ಹಕ್ಕಿದೆ ಎನ್ನುವುದನ್ನು ಯೋಚಿಸಬೇಕು. ಅದಕ್ಕೂ ಮೊದಲು ಅವರ ಮುಂದೆ ನನ್ನ ಪಾಪಗಳನ್ನು ಹೇಳಿಕೊಳ್ಳುವ ವ್ಯಕ್ತಿ ನಾನು ಎಷ್ಟು ಮೂರ್ಖ ಎಂದು ಹೇಳುತ್ತಾನೆ. ಅದರೆ ಪ್ರಸ್ತುತವಾಗಿರುವ ಎಷ್ಟು ಜನ ಯೇಸುವಿನ ಜೊತೆ ಬಾಳಿದವರು, ಯಾರೋ ಹೇಳಿರುವ ವಿಷಯಗಳನ್ನು ನಾವು ಆಚರಿಸುತ್ತೇವೆ. ಅವು ಎಷ್ಟರ ಮಟ್ಟಿಗೆ ಸತ್ಯ, ಸುಳ್ಳು ಎನ್ನುವುದನ್ನು ಮರೆಯುತ್ತಿದ್ದೇವೆ. ಗುರುಗಳು ತುಂಬ ಪವಿತ್ರವಾಗಿರುತ್ತಾರೆ, ಅವರು ಯಾವುದೇ ರೀತಿಯ ಕೆಟ್ಟ ಕೆಲಸ ಮಾಡುವುದಿಲ್ಲ, ಅವರು ತುಂಬ ಪವಿತ್ರರು ಎಂದು ನಂಬುತ್ತೇವೆ. ಇದೆಲ್ಲ ಸತ್ಯ ಎಂದು ನಂಬುವ ನಾವು-ಉದಾ: ಕೆಲವು ದಿನಗಳ ಹಿಂದೆ ಕೇರಳದಲ್ಲಿ ಬಿಷಪ್ ಒಂದು ಕನ್ಯೆಯ ಮೇಲೆ ಆತ್ಯಾಚಾರವೆಸಗಿದ್ದಾರೆ ಎಂದು ಸುದ್ದಿ ಸಿಕ್ಕಗ ಅವರನ್ನು ಪವಿತ್ರ ವ್ಯಕ್ತಿ ಎಂದು ನಂಬಿದ ಜನಗಳೇ ಅವರ ವಿರುದ್ಧ ಹೋರಾಡಲು ಪ್ರಾರಂಭಿಸಿದರು. ಅಂದರೆ ಈ ಎರಡು ವಿಷಯಗಳಲ್ಲಿ ಯಾವುದು ಸತ್ಯ? ನನ್ನ ವೈಯಕ್ತಿಕ ಅನಿಸಿಕೆಯ ಪ್ರಕಾರ ನಾವು ನಮ್ಮ ಜೀವನದಲ್ಲಿ ಒಳ್ಳೆಯವರಾಗಿ ಪ್ರಾಮಾಣಿಕವಾಗಿ ಬಾಳಿದರೆ ಈ ಧಾರ್ಮಿಕ ಆಚರಣೆಗಳು, ಈ ಪಾಪನಿವೇದನೆ ಯಾವುದರ ಅವಶ್ಯಕತೆಯೂ ಇರುವುದಿಲ್ಲ. ಯಾವ ಸ್ವರ್ಗ ಅಥವಾ ನರಕದ ಭಯವು ಇರುವುದಿಲ್ಲ ಯಾಕೆಂದರೆ ಯಾರು ಕೂಡ ಈ ಎರಡು ಸ್ಥಳಗಳನ್ನು ನೋಡಿ ಬಂದು ಹೀಗೆ ಇದೆ, ಹಾಗೇ ಇದೆ ಎಂದು ಹೇಳಲಿಲ್ಲ. ಹಾಗೆ ಯಾವುದೇ ದೇವರು ನನಗೆ ಪೂಜೆ ಮಾಡಬೇಕಾದರೆ ಇಷ್ಟೆ ದುಡ್ಡು ಕೊಡಬೇಕು ಎಂದು ಹೇಳಲಿಲ್ಲ. ನಾವು ಒಳ್ಳೆಯವರಾಗಿದ್ದರೆ ನಮಗೆ ನಾವೇ ದೇವರು, ಒಳ್ಳೆಯ ಕೆಲಸಗಳಲ್ಲೇ ಸ್ವರ್ಗವನ್ನು ಕಾಣಬಹುದು. ಹಾಗೆ ಕೆಟ್ಟವರಾಗಿದ್ದರೆ ಅದೇ ಸೈತಾನ, ನಾವು ನರಕವನ್ನು ಕಾಣಬಹುದು.

ಇನ್ನೂ ನಾವು ರಾಜಕೀಯದ ವಿಷಯಕ್ಕೆ ಬಂದರೆ ಹಲವು ವಿಷಯವನ್ನು ನೋಡಬಹುದು. ರಾಜಕೀಯವು ಪ್ರತಿಯೊಂದು ಪ್ರಜೆಯ ಮೇಲೆ ಅಪಾರ ಪ್ರಭಾವವನ್ನು ಬೀರುತ್ತದೆ. ಕೆಲವೊಂದು ಜನರು ಧಾರ್ಮಿಕತೆಗಿಂತ ರಾಜಕೀಯವನ್ನು ಹೆಚ್ಚು ಅವಲಂಬಿಸಿದ್ದಾರೆ. ಮೊದಲಿಗೆ ರಾಜಕೀಯ ಎನ್ನುವುದು ಎಷ್ಟರ ಮಟ್ಟಿಗೆ ಸತ್ಯ. ಅದು ಯಾವ ರೀತಿಯಲ್ಲಿ ತನ್ನ ಕಾರ್ಯವನ್ನು ಮುನ್ನಡೆಸುತ್ತದೆ ಎಂದು ತಿಳಿದುಕೊಳ್ಳುವುದು ಅವಶ್ಯಕ. ಪ್ರಸುತ್ತ ರಾಜಕೀಯಕ್ಕೂ ಮೊದಲಿನ ರಾಜಕೀಯಕ್ಕೂ ಅಜಗಜಾಂತರ ವ್ಯತ್ಯಾಸವನ್ನು ನಾವು ಕಾಣಬಹುದು. ಈ ಒಂದು ವಿಷಯದಲ್ಲಿ ಜನರು ಜನರಲ್ಲೇ ಸತ್ಯ ಎನ್ನುವ ಪದದಲ್ಲಿ ಮೋಸ ಹೋಗುತ್ತಿದ್ದಾರೆ, ಮೋಸ ಮಾಡುತ್ತಿದ್ದಾರೆ. ಚುನಾವಣೆಗೂ ಮೊದಲು ರಾಜಕಾರಣೆಗಳು ಪ್ರತಿಯೊಂದು ಮನೆ ಮನೆಗೆ ಹೋಗಿ ನಾವು ಬಡವರ ಪರವಾಗಿ ಇದ್ದೇವೆ, ನಾನು ಸವಲತ್ತುಗಳನ್ನು ಕೊಡುತ್ತೇವೆ ಇದು ಸತ್ಯ ಎಂದು ಜನರ ಮುಂದೆ ಕಂಡ ಕಂಡ ದೇವರುಗಳ ಮೇಲೆ ಅಣೆ ಮಾಡಿ ಹೇಳುತ್ತಾರೆ. ಅದರೆ ಅವರು ಆಡಿದ ಮಾತಿನಂತೆ ಚುನಾವಣೆಯಲ್ಲಿ ಗೆದ್ದ ಮೇಲೆ ಸತ್ಯವಾಗಿಯೂ ಮಾಡಿತೋರಿಸುತ್ತಾರೆಯೇ ಎನ್ನುವುದನ್ನು ಯೋಚಿಸಬೇಕು. ಇಲ್ಲಿ ಕೂಡ ನಮ್ಮನ್ನು ನಾವೇ ಮೋಸ

ಸಂವಿಧಾನದಲ್ಲಿರುವ ಅನುಚ್ಛೇದ 370 ಕೇವಲ ಕಾಶ್ಮೀರಕ್ಕೆ ಮಾತ್ರವಲ್ಲದೇ ಭಾರತದ ಇತರ ರಾಜ್ಯಗಳಿಗೂ ಅನ್ವಯವಾಗುತ್ತದೆ. ಆದರೆ ತೀವ್ರ ಪ್ರಮಾಣದಲ್ಲಿ ಅದು ಸಮಸ್ಯೆಯಾಗಿ ಕಾಡುತ್ತಿರುವುದು ಕೇವಲ ಕಾಶ್ಮೀರದಲ್ಲಿ ಮಾತ್ರ. ಸ್ವಾತಂತ್ರ್ಯ ಬಂದ ಪೂರ್ವದಲ್ಲಿ ಸಣ್ಣಮಟ್ಟ ಸಂಸ್ಥಾನಗಳು ಭಾರತದೊಂದಿಗೆ ವಿಲೀನವಾಗಲು ಬಂದಾಗಕಾಶ್ಮೀರ ಮಾತ್ರ ಸ್ವತಂತ್ರ್ಯವಾಗಿ ಉಳಿಯಲು ಬಯಸಿತ್ತು. ಇದಕ್ಕೆ ಮುಖ್ಯಕಾರಣ ಪಂಡಿತ್ ನೆಹರು ಮತ್ತು ಕಾಶ್ಮೀರದ ರಾಜ ಹರಿಸಿಂಗ್ ಮಧ್ಯೆ ಇದ್ದಂತಹ ಭಿನ್ನಮತ. ಇನ್ನೊಂದು ಕಡೆ ಕಾಶ್ಮೀರವನ್ನು ತನ್ನರಾಷ್ಪಕ್ಕೆ ಸೇರಿಸಿಕೊಳ್ಳಬೇಕೆಂಬುದು ಪಾಕಿಸ್ಥಾನದ ಇಚ್ಚೆಯಾಗಿತ್ತು. ತನ್ನ ಉದ್ದೇಶವನ್ನು ಇಡೇರಿಸಲು ಅವಕಾಶಕ್ಕಾಗಿ ಕಾಯುತ್ತಿದ್ದ ಪಾಕ್, ಭಾರತ ಮತ್ತು ಕಾಶ್ಮೀರದ ರಾಜನ ನಡುವೆ ಇದ್ದಂತಹ ಭಿನ್ನಾಭಿಪ್ರಾಯವನ್ನು ಉಪಯೋಗಿಸಿಕೊಳ್ಳುತ್ತದೆ. ಕಾಶ್ಮೀರದ ಪ್ರದೇಶಗಳ ಮೇಲೆ ದಾಳಿಯನ್ನು ಮಾಡುತ್ತದೆ. ಇದರಿಂದಾಗಿ ಸಾವಿರಾರು ಕಾಶ್ಮೀರಿಗಳು ತಮ್ಮ ಪ್ರಾಣ, ಮಾನ ಕಳೆದುಕೊಳ್ಳುತ್ತಾರೆ. ಹೀಗೆ ಕಾಶ್ಮೀರದ ಕೆಲವು ಪ್ರದೇಶಗಳು ಪಾಕಿಸ್ಥಾನದ ವಶವಾಗುತ್ತದೆ. ಇಂತಹ ದುಸ್ಥಿತಿಯಲ್ಲಿ ಕಾಶ್ಮೀರದ ರಾಜ ಜಮ್ಮುವಿಗೆ ಬಂದುಅಲ್ಲಿನ ಸೈನದ ಸಹಾಯವನ್ನು ಯಾಚಿಸುತ್ತಾನೆ, ಆದರೆ ರಾಜನಿಗೆ ಅಲ್ಲಿನ ಸೈನವು ಸಹಾಯವನ್ನು ಮಾಡಲು ನಿರಾಕರಿಸುತ್ತದೆ, ಅನಿವಾರ್ಯ ಪರಿಸ್ಥಿತಿಯಲ್ಲಿ ಕಾಶ್ಮೀರವನ್ನು ಭಾರತದೊಂದಿಗೆ ವಿಲೀನ ಮಾಡುವ ಒಪ್ಪಂದವನ್ನು ರಾಜ ಹರಿಸಿಂಗ್ ಮಾಡಿಕೊಳ್ಳುತ್ತಾನೆ ಹಾಗೂ ಇದರೊಂದಿಗೆ ಕಾಶ್ಮೀರವೂ ಭಾರತದೊಂದಿಗೆ ಸೇರಿಕೊಳ್ಳುತ್ತದೆ.
