At SDM Law we strongly believe that practical exposure is the best form of learning the law. The graduating batches of 2019 have undergone internships at law chambers throughout the year. Weekly court visits are mandatory as a part of the course. Apart from this, internships during the winter and summers breaks are highly encouraged. Over 580 students have interned from reputed law firms, Law associates/chambers, Judicial academy, Law ministry, CBI, Bio- Diversity Board, patent and trade mark offices, NGOs, corporate offices, compliance depts., revenue, police departments and research units. With a view to ease the transition from education to employment, the Training and Placement cell apart from conducting the annual placement hosts skill development program's and encourages the students to intern with various organizations.

In the year 2018, the annual placement named “Legal Career Path’18” was successfully conducted with the presence of over 18 recruiters and 59 students were placed. Beginning of the academic year 2018- 2019 witnessed various pre placement talks such as:

1. Legal Conclave’18, which hosted 15 legal professionals, majority of whom were alumni of our college.
