Sir pointed out that the major difference between Independence day and Republic Day is that Republic day set forth the Constitutional rights and from then the citizens actually became Independent. Sir also mentioned that the Constitution is the rule book which says how government should run. Sir enlightened the students regarding the virtues of Sri. B R Ambedkar on our Constitution. He stressed that Constitution is not a permanent law and that it should be amended. Sir gave students an idea about the Law practice in Supreme court and he also shared his personal experiences of practicing Constitutional Law.

The session was followed by 'question and answer session where he addressed various questions and doubts of the students. It was indeed an excellent learning experience, broadening the knowledge of students on the particular subject.




